## **INSTRUCTIONS FOR COMPLETING FORM 1**

**IMPORTANT :** In order to avoid any delay in processing your application, you <u>MUST</u> follow the instructions when completing Form 1.

#### **1. General Instructions**

- $\sqrt{}$  Use only black pen.
- $\sqrt{}$  Do NOT write name or address outside the rectangular boxes.
- $\sqrt{}$  Do NOT write on unused boxes, leave them blank.
- $\sqrt{}$  Do NOT write on boxes reserved for official use only.
- $\sqrt{}$  Do NOT scratch or abrade any cornerstone or form indicator.

## 2. Instructions for Claimant(s) Section

- $\sqrt{}$  Insert claimant's full name in the name box.
- $\sqrt{}$  Insert claimant's full address in the address box.
- $\sqrt{}$  Insert only 1 name / address in each corresponding box.
- $\sqrt{}$  If there are more than 1 address for the claimant, use another claimant column(s) to fill in the addresses, but do NOT fill in the name box(es) of that claimant column(s).
- $\sqrt{}$  If there are more than 2 claimants, please refer to instruction no. 4.
- $\sqrt{}$  For representative claim, insert full name and address of each person.

# **3.** Instructions for Defendant(s) Section

- $\sqrt{}$  Insert defendant's full name in the name box.
- $\sqrt{}$  Insert defendant's full address in the address box.
- $\sqrt{}$  Insert only 1 name / address in each corresponding box.
- $\sqrt{}$  If there are 1 to 3 addresses for a defendant, insert the addresses into the address boxes below the defendant's name box.
- $\sqrt{}$  Addresses filled in a defendant column MUST belong to the same defendant.
- $\sqrt{}$  If there are more than 3 addresses for the defendant, use other defendant column(s) to fill in the addresses, but do NOT fill in the name box(es) of that defendant column(s).
- $\sqrt{}$  If there are more than 2 defendants, please refer to instruction no. 4.
- $\sqrt{}$  If a defendant is a business entity with a trading name, please refer to instruction no. 5.

### 4. Instructions for Multiple Claimant(s) / Defendant(s)

- $\sqrt{}$  Use as many pages of Form 1 as required.
- $\sqrt{}$  Each page of Form 1 should comply with the instructions above.
- $\sqrt{}$  Sort all pages of Form 1 to show the correct relationship of names and addresses.
- $\sqrt{}$  Insert page number on each page of Form 1.

#### 5. Instructions for Business Entity with a Trading Name as Defendant

 $\sqrt{}$  Sole proprietorship

Name of proprietor in a business entity with a trading name MUST be inserted into 1 name box.

Example:

Chan Tai Man t/a Chan Tai Man Trading Company

Insert the business address into the address box below the name box. If there is a personal address, insert the address in another address box below the name box.

 $\sqrt{}$  Business partnership

Names of all partners in a business entity with a trading name MUST be inserted into separate name boxes and sued as individual defendants.

Example:

Chan	Tai	Man,
partner	of	Tai
Chung	Siu T	rading
Company		

Chan Chung Man, partner of Tai Chung Siu Trading Company

Chan Siu Man, partner of Tai Chung Siu Trading Company In respect of each partner, insert the business address into the address box below the respective name box. If there is a personal address, insert the address in another address box below the respective name box.

 $\sqrt{}$  This instruction does not apply to suing against law firm as defendant and, in which case, only the name of the firm is required to be inserted into 1 name box.

Example:

Tai Chung Siu Solicitors

Insert the firm address into the address box below the name box.

 $\sqrt{}$  If there is a defendant in addition to the business entity, please follow instruction no. 3.

# 6. Instructions for Submitting Photocopy of Form 1

- $\sqrt{}$  Photocopy MUST include the 4 cornerstones and form indicator.
- $\sqrt{}$  Photocopy MUST be exactly the same size of the standard Form 1.
- $\sqrt{}$  Blurred photocopy is NOT acceptable.
