Work of JORC

1. Discussions and decisions on recommendations on judicial appointments were made usually through meetings and occasionally by circulation of papers. In the year 2024, three meetings were held at which 16 papers were discussed. JORC passed resolutions on 43 recommendations on judicial appointments which were accepted by the Chief Executive (CE), comprising 33 recommendations relating to new appointments, eight relating to extension of term of office, and two on renewal of contracts. Details are at pages 6 and 7.

1. Bio-data of the Chairman and Members of JORC

Chairman

The Honourable Chief Justice Andrew CHEUNG Kui-nung, GBM

Chief Justice Cheung read law at the University of Hong Kong, graduating with a Bachelor of Laws degree in 1983 and a Postgraduate Certificate in Laws in 1984. In 1985, he obtained a Master of Laws degree from Harvard Law School. He was called to the Hong Kong Bar in the same year, and in 1995 he was admitted as an Advocate and Solicitor of the Supreme Court of Singapore.

Chief Justice Cheung was in private practice in Hong Kong before joining the Judiciary as a District Judge in 2001. He started deputising as a Deputy High Court Judge in December 2001 and was appointed a Judge of the Court of First Instance of the High Court in 2003. Chief Justice Cheung was made the Probate Judge in 2004 and the Judge in charge of the Constitutional and Administrative Law List in 2008.

In 2011, Chief Justice Cheung was appointed the Chief Judge of the High Court and became the President of the Court of Appeal of the High Court. In October 2018, Chief Justice Cheung was appointed a Permanent Judge of the Court of Final Appeal. In January 2021, he was appointed the Chief Justice of the Court of Final Appeal.

Chief Justice Cheung was made an Honorary Bencher of Lincoln's Inn in 2017. He was awarded the Grand Bauhinia Medal in 2021.

Secretary for Justice, The Honourable Paul LAM Ting-kwok, GBS, SC, JP

Mr Paul Lam, SC, was appointed Secretary for Justice on 1 July 2022.

Before joining the Government, Mr Lam was a Senior Counsel in private practice specialising in general civil and commercial proceedings, and has passed the Guangdong-Hong Kong-Macao Greater Bay Area Legal Professional Examination. He was a former Vice-Chairman of the Hong Kong Bar Association from 2014 to 2017 and the Chairman from 2017 to 2018. He sat as a Deputy Judge of the High Court of Hong Kong for short periods each year since 2015. He was once enlisted in the Panel of Arbitrators of the Shenzhen Court of International Arbitration and The China International Economic and Trade Arbitration Commission, and was once appointed by the China University of Political Science and Law in Beijing as professor.

Mr Lam held a number of public service positions, such as Chairman of the Consumer Council, Chairman of the Administrative Appeals Board, Chairman of ICAC Operations Review Committee and Member of Independent Police Complaints Council.

Members

The Honourable Mr Justice Jeremy POON Shiu-chor

Mr Justice Poon obtained the Bachelor of Laws degree and the Postgraduate Certificate in Laws both from the University of Hong Kong in 1985 and 1986 respectively. He further acquired the Master of Laws degree from the University College London in the United Kingdom in 1987. He was called to the Hong Kong Bar in 1986 and was in private practice between 1988 and 1993.

Mr Justice Poon joined the Judiciary as Magistrate in 1993. He was appointed as Deputy Registrar, High Court in 1999, and as Judge of the Court of First Instance of the High Court in 2006. While in the Court of First Instance, Mr Justice Poon was appointed the Civil Listing Judge, the Probate Judge, the Judge in charge of the Mental Health List and the Family Law List. In 2015, he was appointed as Justice of Appeal of the Court of Appeal of the High Court. He has been appointed as the Chief Judge of the High Court since 18 December 2019.

Mr Justice Poon chairs or is a member of various committees and working parties within the Judiciary.

The Honourable Madam Justice Carlye CHU Fun-ling

Madam Justice Chu graduated from the University of Hong Kong with a Bachelor of Laws degree in 1982 and a Postgraduate Certificate in Laws in 1983. In 1984, she obtained a Master of Laws degree from London School of Economics and Political Science. She obtained a Master of Social Sciences degree in Criminology from the University of Hong Kong in 1994.

Madam Justice Chu was called to the Hong Kong Bar in 1983. She was in private practice before joining the Judiciary in 1991 as Magistrate. She was appointed as District Judge in 1995, Deputy Registrar of the High Court in 1997, Registrar of the High Court in 1999 and Judge of the Court of First Instance of the High Court in 2000. She was appointed as Justice of Appeal of the Court of Appeal of the High Court in 2011 and was appointed as a Vice-President of the Court of Appeal of the High Court in 2022.

Madam Justice Chu has been serving on various committees and working parties within the Judiciary. She is an Honorary Lecturer in the Department of Professional Legal Education of the Faculty of Law of the University of Hong Kong.

Mr Victor DAWES, BBS, SC

Mr Dawes, SC, read law at the London School of Economic and Political Science and graduated with a Bachelor of Laws degree in 1998. He then obtained his Postgraduate Certificate in Laws at the University of Hong Kong in 1999.

Mr Dawes was called to the Hong Kong Bar in 1999 and was appointed Senior Counsel in 2015. He was Chairman of the Hong Kong Bar Association from 2022 to 2024. He is also a Recorder of the Court of First Instance of the High Court and a non-executive director of the Securities and Futures Commission. Mr Dawes was awarded the Bronze Bauhinia Star in 2024.

Ms Melissa Kaye PANG, BBS, MH, JP

Ms Pang is the Past President of the Law Society of Hong Kong. She was elected the first female President of the Law Society of Hong Kong in 2018, and re-elected in 2019 and 2020. Ms Pang currently serves as Chairperson of Diversity and Inclusion Committee; Member of Standing Committee on Policy and Resources, External Affairs, Member Services and Mediation Committee. She was the Founding Chairperson of International Legal Affairs Committee and Pro Bono Committee.

Ms Pang is qualified to practise as a solicitor in Australia, England & Wales and Hong Kong. She is a Notary Public, Civil Celebrant, accredited mediator, Council Member of the Hong Kong Mediation Accreditation Association Limited and China Appointed Attesting Officer. She is also the Past President of LAWASIA.

Ms Pang is the Chairman of the Family Council, the Hong Kong Press Council and the Agency for Volunteer Service. She is the Chief Commissioner of the Hong Kong Girl Guides Association. She is also a member of Operations Review Committee of the Independent Commission Against Corruption, Hong Kong Housing Authority and the Women's Commission. With her devotion to public service, Ms Pang was awarded the Medal of Honour by the Hong Kong Special Administrative Region Government in 2006, Justice of the Peace in 2010 and the Bronze Bauhinia Star in 2020.

Mr Carlson TONG, GBS, JP

Mr Tong is the Chairman of Hong Kong Exchanges and Clearing Limited. He is also an Independent Non-Executive Director of MTR Corporation Limited and the Hong Kong Investment Corporation Limited; and a director of the World Federation of Exchanges.

Mr Tong was Chairman of KPMG China and Hong Kong from 2007 to 2011, and was Chairman of the Asia-Pacific region and a member of KPMG's global board from 2009 to 2011. He was also an independent non-executive director of Standard Chartered PLC.

Mr Tong has been actively involved in capital markets throughout his career, with profound expertise in corporate governance and regulatory compliance. He served as a member of the Main Board and Growth Enterprise Market Listing Committee of The Stock Exchange of Hong Kong Limited from 2002 to 2006 before becoming the chair from 2006 to 2008.

Mr Tong was appointed Chairman of the Securities and Futures Commission from 2012 to 2018. He oversaw the launch of several major policy initiatives during his term, including the introduction of the landmark Stock Connect programme and the mutual recognition of funds between Mainland China and Hong Kong.

Mr Tong has also been very active and devoted in serving the community, particularly in the education and youth sectors. He was Chairman of the English Schools Foundation, the Hong Kong Sports Institute and the University Grants Committee of Hong Kong.

Mr Tong is a Fellow of both the Institute of Chartered Accountants in England and Wales (ICAEW) and the Hong Kong Institute of Certified Public Accountants. He received the 2022 ICAEW Outstanding Achievement Award, and was awarded an honorary Doctor of Business Administration by The Hong Kong University of Science and Technology, as well as an honorary Doctor of Social Sciences by The Education University of Hong Kong.

Mr Tong was awarded the Silver Bauhinia Star and the Gold Bauhinia Star by the Hong Kong Special Administrative Region Government in 2014 and 2019 respectively.

Mrs Pamela CHAN WONG Shui, BBS, JP

(up to 30 June 2024)

Mrs Chan is Chairman of the Insurance Complaints Bureau, The Boys' and Girls' Clubs Association of Hong Kong and Third Vice President of the Community Chest.

Mrs Chan had been the Chief Executive of the Consumer Council for 22 years and an Independent Non-Executive Director of MTR Corporation for 10 years until May 2023. She was Chairman of the Hong Kong Deposit Protection Board, Deputy Chairman of the Hong Kong Baptist University Council and the Court, Chairman of the governing committee of Princess Margaret Hospital and Chairman of the Departmental Advisory Committee of the Department of Social and Behavioral Sciences of the City University of Hong Kong, etc.

On law related appointments, Mrs Chan was a member of the Law Reform Commission of Hong Kong, Standing Committee on Legal Education and Training as well as Postgraduate Certificate in Laws Academic Boards of the University of Hong Kong and the City University of Hong Kong.

Professor Liu Pak-wai, SBS, JP

(up to 30 June 2024)

Professor Liu is Distinguished Research Fellow and Professor Emeritus at The Chinese University of Hong Kong. He was formerly Pro-Vice-Chancellor, Professor of Economics and Founding Director of the Institute of Global Economics and Finance. He is a member of the Advisory Board of the Faculty of Law of The Chinese University of Hong Kong and a member of the Governing Board of The Chinese University of Hong Kong, Shenzhen and the Shenzhen Finance Institute.

Professor Liu received his Bachelor of Arts from Princeton University and Doctor of Philosophy in Economics from Stanford University. He was a Visiting Scholar of the Harvard-Yenching Institute (1981-82) and a Distinguished Fulbright Scholar in 2000-01.

Professor Liu is a Director of the Hong Kong Institute for Monetary and Financial Research of the Hong Kong Monetary Authority. He is an Independent Non-Executive Director of Hang Lung Group Limited and Transport International Holdings Limited. He was a Non-Executive Director of the Securities and Futures Commission.

Besides teaching, research and administration, Professor Liu has been active in public service. He was Chairman of Advisory Committee on Post-office Employment for Former Chief Executives and Politically Appointed Officials. He was a member of Chief Executive's Commission on Innovation and Technology; Commission on Strategic Development; Independent Commission on Remuneration Package and Post-office Arrangements for the Chief Executive of the Hong Kong Special Administrative Region: Independent Commission on Remuneration for Members of the Executive Council and the Legislature, and Officials under the Political Appointment System of the Hong Kong Special Administrative Region; Aviation Development Advisory Committee; Provisional Minimum Wage Commission: Independent Committee for the Prevention and Handling of Potential Conflicts of Interests and Working Group on Long-Term Fiscal Planning; among others.

Professor Liu was awarded the Silver Bauhinia Star in 1999 for "outstanding academic achievement and public service in Hong Kong". He was appointed Justice of the Peace in 2006.

Mr Philip CHEN Nan-lok, GBS, JP

(since 1 July 2024)

Mr Chen is an Independent Non-Executive Director of Hang Lung Properties Limited. He retired as Chief Executive Officer of Hang Lung Group and Hang Lung Properties Limited in July 2018 and became Non-Executive Director of Hang Lung Properties Limited until January 2023.

Prior to joining Hang Lung in July 2010, Mr Chen had been with the Swire Group for thirty-three years. He was Chairman of John Swire & Sons (China) Limited, Chief Executive of Cathay Pacific Airways Limited, Chief Executive Officer of Hong Kong Dragon Airlines Limited, Executive Director of Swire Pacific Limited and John Swire & Sons (Hong Kong) Limited.

Over the years, in Hong Kong as well as overseas, Mr Chen has taken up major roles in various trade and community services. In community services, he has been actively involved mainly in areas relating to corruption prevention, education, commerce, aviation, logistics, tourism, and charities etc. He is also the Chief Editor of one volume of Hong Kong Chronicles.

Mr Chen is the Immediate Past Chairman of the Hong Kong Jockey Club. He is currently a Vice Patron of the Hong Kong Community Chest. He is a Member of the Board of Airport Authority Hong Kong, Member of the Hong Kong-Japan Business Co-operation Committee, Advisor of Our Hong Kong Foundation, Director of both the China Overseas Friendship Association and the Shanghai Chinese Overseas Friendship Association, Honorary President of the Hong Kong Association of China Travel Organizers Limited, and Founder and Honorary President of the Hong Kong Chamber of Commerce in Beijing.

Mr Chen has great passion in education. For his Alma Mater, the University of Hong Kong, he has been appointed Professor of Practice in Management and Strategy of the Faculty of Business and Economics. He conducts an MBA course every year. He is also a Member of the International Advisory Council of the Faculty of Business and Economics, as well as a Member of the Advisory Committee of Shun Hing College.

He has been appointed Professor of Practice (Hospitality and Tourism Strategies), School of Hotel and Tourism Management by The Hong Kong Polytechnic University and Visiting Professor, Department of Management, Faculty of Economics by Sophia University, Tokyo.

He also serves as a Member of the International Advisory Board of Lingnan (University) College, Sun Yat-sen University as well as a Member of the Advisory Board of Stanford Graduate School of Business Chapter of Hong Kong.

Mr Chen has published several bestsellers of travel stories in Hong Kong, two of which have also been published in Beijing and Taiwan. The royalties from the book sales have been donated to two charities. His research on the "Great Cities Theory" has also been published as "Great Cities of the World" by the University of Hong Kong in 2010, and then "Great Cities" in Chinese was also published in 2023.

In 2001, The Hong Kong University of Science and Technology named Mr Chen Honouree of the Beta Gamma Sigma and in 2004, made him an Honorary Doctor of Business Administration. In 2009, he was awarded a Distinguished Alumni Fellowship by The University of Hong Kong School of Professional and Continuing Education, and the University of Hong Kong also admitted him an Honorary University Fellowship in 2013 and bestowed upon him Beta Gamma Sigma Honouree in 2016. In 2010, he was bestowed Honorary Member of Eta Sigma Delta Chapter by The Chinese University of Hong Kong. He was conferred Doctor of Business Administration, honoris causa by Lingnan University in 2014 as well as by the Hong Kong Baptist University in 2018. He was also awarded a Fellowship by the Royal Aeronautical Society of the UK in 1997 and a Fellowship by the Hong Kong Management Association in 2004.

In 2000, Mr Chen was appointed as a Justice of the Peace and awarded the Silver Bauhinia Star in 2002. He was further awarded the Gold Bauhinia Star in 2012. He was bestowed the Distinction of Officier de l'Ordre National du Mérite by the French Government in 2009. In June 2014, the Ministry of Education, Singapore presented him the Service to Education Award – Silver.

Professor Nancy IP Yuk-yu, SBS, BBS, MH, JP (since 1 July 2024)

Professor Ip is the President of The Hong Kong University of Science and Technology (HKUST) and the Morningside Professor of Life Science. Taking office in October 2022, she is the first female president of a publicly funded university in Hong Kong.

Professor Ip received her PhD degree in Pharmacology from Harvard University, after which she held the position of Senior Staff Scientist at Regeneron Pharmaceuticals Inc. in New York. Since joining HKUST in 1993, she has served as the Vice-President for Research and Development, Dean of Science, and Head of the Department of Biochemistry.

World-renowned for her contributions to the field of neuroscience, Professor Ip's research interests include understanding the complex mechanisms underlying brain functions and drug discovery for neurodegenerative diseases such as Alzheimer's disease. Her research has resulted in over 330 scientific papers and 70 patents. In addition to conducting pioneering neuroscience research, she helps shape research policy on a global level. She is a member of various strategic initiatives such as the Leadership Group of the Davos Alzheimer's Collaborative.

A distinguished neuroscientist, Professor Ip is an elected member of the Chinese Academy of Sciences, the US National Academy of Sciences, the American Academy of Arts and Sciences, the World Academy of Sciences, the Chinese Academy of Medical Sciences, and the Hong Kong Academy of Sciences, among other academies. In recognition of her excellence in science. Professor Ip has received numerous awards and honors. She received the L'OREAL-UNESCO for Women in Science Award for her discoveries on the molecular control of growth, differentiation, and synapse formation in the nervous system. She was the first Chinese scientist in the Life Sciences to receive this distinguished award. She was also bestowed the title and rank of "Chevalier de l'Ordre National du Mérite" by the French Government in recognition of her scientific contribution to the community. Her other notable awards include the National Natural Science Awards, the Honors for Women Innovators at the APEC Women and Economy Summit, and the "10 Science Stars of China" by Nature.

Professor Ip has been actively serving on important boards and committees in community service, including the Chief Executive's Council of Advisers, to help steer the strategic development of Hong Kong. Moreover, as the Council Chair and founding member of the Greater Bay Area Association of Academicians, she has been fostering co-operation among academics in Hong Kong and the Mainland, to help advance science and technology in the Greater Bay Area.

Professor Ip was awarded the Silver Bauhinia Star, Bronze Bauhinia Star, Justice of the Peace, and the Medal of Honor from the Hong Kong Special Administrative Region Government.
